Contract and Terms

1. **Equipment** - The undersigned, as the lessee, hires from Jump Around, llc, the lessor, the described units on the reverse of this rental agreement. The rental fee is due in full prior to or at the time of delivery.

2. **Delivery** - The lessee grants to Jump Around, llc rights to enter the property listed as the delivery address, on reverse side of this agreement, for the purpose of delivery and pick up of the rented items listed on the reverse side of this agreement.

3. **General Rules of Safe Operation** –

- All participants **MUST REMOVE** shoes, sharp object, jewelry and eyeglasses before entering the units
- **NO FOOD OR DRINKS** are allowed in the units
- **NO SILLY STRING**
- To avoid injury – the following are **NOT ALLOWED**, Flips, Wrestling, Horseplay or any other unsafe activity both in and around the units.
- An adult (18 year old or older) will be present and supervising at all times.
- Any person violating posted rules of operation is to be removed from the unit.
- Children of the same size and age group only may use the units at any given time, no adults.
- In the event of High Wind, as defined below, and/or Rain, the lessee has been instructed to get all participants off the units and how to properly disconnect the power from the units.
- The lessee has been shown how to turn the power on and off of the blower.
- The lessee has been shown how the unit is properly secured.
- Capacities – **8 and under** – no more than **8** at one time : **9 – 12** – no more than **6** at one time : **Teens** no more than **3** at one time

_____ By initialing here the lessee acknowledges that they have read and understand the above rules of safe operation.

4. **Safe Operation Acknowledgment** - Lessee acknowledges that they have been instructed about and fully understand the safe operation of the units that are the subject of this rental agreement. Lessee agrees to observe all safety precautions and is to be held responsible for any injury related & shall not hold claims against Jump Around, llc for any injuries. Lessee also represents and warrants the safe return of the rented units and here by agrees to pay the replacement cost and loss of use costs, up to a total of \$5,000.00, if the unit is not returned in the same clean, working condition. Ordinary wear and tear is expected.

5. **RELEASE OF LIABILITY** - The Lessee shall be in charge of the units operation and is fully responsible for it's safe operation as well as return of the unit in good working order. Lessor is not responsible for injury occurring to the lessee or to any other persons using the rental equipment, and the Lessee further agrees to hold the Lessor free and harmless against injury or claim. Should legal action be necessary, the Lessee shall indemnify the Lessor from/against any costs incurred due to claims from anyone and for attorney's fees and related costs involving the use and return of the units.

6. **Cancellations** - Cancellation will be accepted 10 business days prior to the rental date for a 100% refund of the deposit. Cancellations made less than 10 business days will be issue a Gift Certificate by mail for the Deposit amount only if the unit reserved is rented. See below for Weather Cancellations.

7. **Weather Policy/Cancellations** – If the local weather is calling for Rain and/or the lesser of wind greater than the Manufacturer guidelines or 20 mph, the customer and Jump Around must agree that reserved date and time would be lost, the customers deposit will be applied to another rental day, as long as it is used during that calendar year.


There will be **NO REFUND** once the units has been delivered and/or set up and there is Rain or High winds. If there is Rain or High winds after set up the Unit **MUST NOT BE USED**. Once the weather returns to favorable conditions, rain stops or wind slows, the unit should be inspected for moisture and dried, then operation can be resumed.
